GUIDELINES

GENERAL GUIDELINES

- The author(s) can send their submissions on editorial.rhcba@gmail.com
- All manuscripts submitted, must be original and should not have been published elsewhere.
- All manuscripts will be checked for plagiarism. If plagiarism is detected, the Editorial Board reserves the right of rejection without a review of the manuscript.
- The title of the manuscript should indicate the sub-theme that the author(s) have chosen.
- Upon submission, every manuscript will undergo an internal review by the Board of Editors.
- Authors must note that grammatical and legal accuracy, contribution to literature (originality of content), etc. will be some of the major criteria on which the submissions will be analysed. The responsibility for the accuracy of the facts, opinions, or viewpoints stated in the submitted paper shall rest solely with the author(s).

- The Author shall be solely responsible for the content of the submissions and the board or Rajasthan High Court Bar Association Jaipur Blog shall not be responsible for the same.
- The Editorial Board will have the discretion to decide on the publication of the article and the decision of the editorial board will be final.
- Once the article is published by the Editorial Board it shall not be published by the author on any other platform without the written consent of the Board.

SUBMISSION GUIDELINES

I. Submission Categories

- iv. **Legislative Comments**

Legislative Comments: A comment that analyses the objective of the legislation and analyses the legal impact of the same.

II. Instructions for Authors

- All submissions must be in Garamond/times new roman, font size 12, spacing 1.5.
- All footnotes shall be in Garamond 10, single-spaced.
- Margins: Left 1 Inch and Right 1 Inch, Top 1 Inch and Bottom 1 Inch (A4).
- The word limit is exclusive of all the footnotes.
- Co-authorship is allowed up to 2 authors.
- All submissions must be accompanied with a cover letter in a separate document stating the details of the author(s).

- All entries should be submitted in **.doc/ .docx** format **only**.
- The author(s) bear sole responsibility for the accuracy of facts, opinions or views stated in the submitted paper.

IV. Copyright Policy
