

**Significant Accounting Policies & Notes on Accounts**

**A. Significant Accounting Policies**

1. Basis of accounting:-

The financial statements have been prepared under the historical cost convention on Going Concern Basis.

2. Revenue Recognition:-

- (i) Income and receivable are considered and accounted on Cash basis.
- (ii) Expenses and payable was booked on Cash basis.
- (iii) Loans and Advances provided to staff members on which interest is charged by the Association by way of two extra instalments after payment of principal amount of loan.
- (iv) Interest on Fixed Deposit book on accrual basis as per the TDS certificate/statement provided.

3. Fixed Assets:-

Fixed Assets including intangible assets are stated at their original cost of acquisition including taxes, freight and other incidental expenses related to acquisition and installation of the concerned assets less depreciation till date.

4. Depreciation:-

Depreciation on Fixed Assets is provided to the extent of depreciable amount on the Written down Value (WDV) Method as per the rates prescribed in Income Tax Act, 1961.

5. Investments:-

Investments, which are readily realizable and intended to be held for more than one year from the date on which such investments are made, are classified as Long-term investments. The Association has made Long-term investment in Fixed Deposit in State Bank of India and Bank of Baroda which are accounted on Cost basis and interest has been accounted on accrual basis.

6. Retirement Benefits:-

The retirement benefits are accounted for as and when liability becomes due for payment to employee of the association.



7. General:-

Except wherever stated, accounting policies are consistent with the generally accepted accounting principles and have been consistently applied.

**(B) Notes on Financial Statements**

1. Computerized Accounting Process:-

It is recommended for Organization to adopt the fully Computerized Accounting process by up gradation of its existing Customized Software for accounting, inventory management and Inward-Outward of Library Books. Current Software is not compatible with the accounting functions and no any Accounting Reports were generating by this software.

2. Membership Forms:-

There was a large number of membership forms which was entered/ accounted in the system but payment for the same was not received because of the matter related to the previous years so it may have resulted to the loss of revenue to the Association.

3. Loans and Advances:-

The association does not hold any security other than the personal guarantee in respect of loans and advances given to the employees. No any Uniform Policy was made to approve or sanction the Loan amount and advances given/sanctioned to the employees and no any specific method was adopted for recovery or monthly repayment of the advances so given to the employee.

4. Provision for Retirement Benefits:-

No provision for retirement benefits has been made, in view of accounting policy No. 6 and accounted for as and when liability becomes due for payment to employee. The impact of the retirement benefit paid to the employees retired in this year is given on Income and Expenditure A/c.

5. Inventories Records:-

Since organization is not engage in any manufacturing and trading activity so no Inventory Register is maintained by the organization. Quantity wise details of the members Directory and Calendar printed for the year under consideration was maintained for reference purpose.

6. Fixed Assets:-

Opening Balances of Fixed assets has been taken on the basis of Audited Balance sheet for the year 2023-24. Register of fixed assets are not maintained by the association so physical verification was done on the basis of balances showing in Balance sheet and quantity wise details of the same has been reported on the basis of physically verified items available in the Bar office premises.

A handwritten signature in blue ink, appearing to read "A. N. N.", is placed over a faint circular watermark in the bottom right corner of the page.

7. Tax Deducted at Source:-

TDS was Deducted by the parties was accounted in the Books of accounts but credit of amount of TDS has not been claimed due to not filling of Income tax return by due date.

8. Electricity Expenses Payable:-

Balance payable to Electricity department was reported in Balance sheet has been taken on the basis of Audited Balance sheet for the year 2023-24.

9. Misc. Receipts:-

Some income received in Bank account is accounted in the Books of accounts but No receipts was found for the same.

10. Cash Balance: -

It was found that cash was accumulated in the hand of Cashier/Accountant due to the non-deposit in the Bank account on daily basis so Closing Balance of Cash was very high by the end of the financial year. Due to the excess cash maintained by the Cashier/ Accountant in his hand, Association suffered a loss of income that may have been earned by receiving interest from the Bank if cash was timely deposited into the Bank account.

11. Cash Embezzlement

Auditor found that in the month of August 2023 cashier of the Association was found guilty for his fraudulent activity. According to the discussion with the management, he was involved in embezzlement of the cash for which an FIR against that Employee was lodged and a case was filed for recovery of the embezzled amount, out of which Rs. 25 Lac was recovered from him in the year 2023-24 and remaining balance of Rs. 3152373.00 is still recoverable. Management is recommended to gear-up the efforts to recover the amount so Embezzlement.

**Significant Accounting Policies & Notes on Accounts**

**A. Significant Accounting Policies**

1. Basis of accounting:-

The financial statements have been prepared under the historical cost convention on Going Concern Basis.

2. Revenue Recognition:-

- (i) Income and receivable are considered and accounted on Cash basis.
- (ii) Expenses and payable was booked on Cash basis.
- (iii) Loans and Advances provided to staff members on which interest is charged by the Association by way of two extra instalments after payment of principal amount of loan.
- (iv) Interest on Fixed Deposit book on accrual basis as per the TDS certificate/statement provided.

3. Fixed Assets:-

Fixed Assets including intangible assets are stated at their original cost of acquisition including taxes, freight and other incidental expenses related to acquisition and installation of the concerned assets less depreciation till date.

4. Depreciation:-

Depreciation on Fixed Assets is provided to the extent of depreciable amount on the Written down Value (WDV) Method as per the rates prescribed in Income Tax Act, 1961.

5. Investments:-

Investments, which are readily realizable and intended to be held for more than one year from the date on which such investments are made, are classified as Long-term investments. The Association has made Long-term investment in Fixed Deposit in State Bank of India and Bank of Baroda which are accounted on Cost basis and interest has been accounted on accrual basis.

6. Retirement Benefits:-

The retirement benefits are accounted for as and when liability becomes due for payment to employee of the association.



7. General:-

Except wherever stated, accounting policies are consistent with the generally accepted accounting principles and have been consistently applied.

**(B) Notes on Financial Statements**

1. Computerized Accounting Process:-

It is recommended for Organization to adopt the fully Computerized Accounting process by up gradation of its existing Customized Software for accounting, inventory management and Inward-Outward of Library Books. Current Software is not compatible with the accounting functions and no any Accounting Reports were generating by this software.

2. Membership Forms:-

There was a large number of membership forms which was entered/ accounted in the system but payment for the same was not received because of the matter related to the previous years so it may have resulted to the loss of revenue to the Association.

3. Loans and Advances:-

The association does not hold any security other than the personal guarantee in respect of loans and advances given to the employees. No any Uniform Policy was made to approve or sanction the Loan amount and advances given/sanctioned to the employees and no any specific method was adopted for recovery or monthly repayment of the advances so given to the employee.

4. Provision for Retirement Benefits:-

No provision for retirement benefits has been made, in view of accounting policy No. 6 and accounted for as and when liability becomes due for payment to employee. The impact of the retirement benefit paid to the employees retired in this year is given on Income and Expenditure A/c.

5. Inventories Records:-

Since organization is not engage in any manufacturing and trading activity so no Inventory Register is maintained by the organization. Quantity wise details of the members Directory and Calendar printed for the year under consideration was maintained for reference purpose.

6. Fixed Assets:-

Opening Balances of Fixed assets has been taken on the basis of Audited Balance sheet for the year 2023-24. Register of fixed assets are not maintained by the association so physical verification was done on the basis of balances showing in Balance sheet and quantity wise details of the same has been reported on the basis of physically verified items available in the Bar office premises.



7. Tax Deducted at Source:-

TDS was Deducted by the parties was accounted in the Books of accounts but credit of amount of TDS has not been claimed due to not filling of Income tax return by due date.

8. Electricity Expenses Payable:-

Balance payable to Electricity department was reported in Balance sheet has been taken on the basis of Audited Balance sheet for the year 2023-24.

9. Misc. Receipts:-

Some income received in Bank account is accounted in the Books of accounts but No receipts was found for the same.

10. Cash Balance: -

It was found that cash was accumulated in the hand of Cashier/Accountant due to the non-deposit in the Bank account on daily basis so Closing Balance of Cash was very high by the end of the financial year. Due to the excess cash maintained by the Cashier/ Accountant in his hand, Association suffered a loss of income that may have been earned by receiving interest from the Bank if cash was timely deposited into the Bank account.

11. Cash Embezzlement

Auditor found that in the month of August 2023 cashier of the Association was found guilty for his fraudulent activity. According to the discussion with the management, he was involved in embezzlement of the cash for which an FIR against that Employee was lodged and a case was filed for recovery of the embezzled amount, out of which Rs. 25 Lac was recovered from him in the year 2023-24 and remaining balance of Rs. 3152373.00 is still recoverable. Management is recommended to gear-up the efforts to recover the amount so Embezzlement.


