1. 2. The Trust is created for providing payment to legal heir/nominee of the trust member in case of death of a fund member and to make payment of ex-gratia fund to it's fund member who has suffered serious illness/accident as specified, without any profit motive.

NOW THIS DEED WITNESSETH AS FOLLOWS:

1. Name of the Trust

The name of the Trust shall be "**Rajasthan High Court Bar Association, Jaipur Welfare Trust Fund**".

2. Registered Office

The registered office of the Trust shall be situated at the premises of the Rajasthan High Court Bar Association, Jaipur situated at High Court Building Bhagwan Das Road, Jaipur.

(a) "**Advocate**" means a person whose name has been entered in the State roll of advocates prepared and maintained by the Bar Council of Rajasthan State under Section 17 of the Advocates Act, 1961 (Central Act 25 of 1961) and who is a member of Rajasthan High Court Bar Association, Jaipur Bench;

(b) "**Bar Association**" means Rajasthan High Court Bar Association, Jaipur registered and recognized by the Bar Council;

(c) "**Trust Fund**" means the "Rajasthan High Court Bar Association, Jaipur Welfare Trust Fund" constituted under Clause 5;

(d) "**Bar Council**" means the Bar Council of Rajasthan State constituted under the Advocates Act, 1961 (Central Act 25 of 1961);

(e) "**Dependents**" means wife, husband, father, mother and unmarried minor children of a member of the Fund and includes his widowed daughter and major children who suffer from physical disability or insanity and who are maintained by him or such of them who survive on his death;

(f) "**Member of the Fund**" means an Advocate member of Rajasthan High Court Bar Association, Jaipur Bench who is admitted to the benefits of the fund under the provisions of this Trust Deed and continues to be a member of RHCBA, Jaipur and Trust Fund thereof;

(g) "**Nominee**" means nominee appointed by a member of the Fund to receive the benefits arising from such membership in the event of his death;

(h) "**Senior Advocate**" means advocate designated as Senior Advocate by Rajasthan High Court under section 16(2) of Advocates Act, 1961.

(i) "**Trustee Committee**" means the Committee established under Clause 6;

(j) "**Vakalatnama**" means and includes memorandum of appearance or any other document by which an advocate is empowered to appear or plead before Rajasthan High Court, Jaipur Bench [but does not include a memorandum of appearance authorising an advocate to appear on behalf of another advocate for the purpose of seeking adjournment only;]

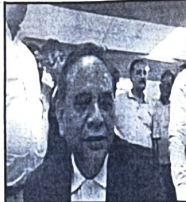

(k) "Working Day" wherever referred shall deemed to be actual working day as per calendar issued by Rajasthan High Court.

(l) "Year" means a period of twelve months commencing from 1st day of April and ending on the 31st day of March next.

(m) "Words and expressions" herein used but not defined shall be construed as defined under Advocates act, 1961.

4. Objects of the Trust

The objects of the Trust shall be of its member welfare-oriented, including:

a) To provide certain asserted fund by way of payment to legal heir/nominee of the member in case of death of the member of fund as fixed by the trustee committee from time to time.

b) To provide certain fund by way of ex-gratia to the member who have suffered serious illness or disability acquired by accident as specified.

5. Trust Fund

A) The Settlor has handed over a sum of Rs. 5000/- (Rupees Five Thousand only) to the Trustees as the initial Trust Fund.

B) All Additions, Donations, Admission Fee, Annual/Lifetime subscriptions fee from members, Grants, and Contributions received from any Individual, Institution, Corporate or Non-corporate entities, State of Rajasthan or Bar Councils and from Rajasthan High Court Bar Association, Jaipur from time to time shall form the Trust Fund.

C) All receipts from the advocates on sale of authorised printed Vakalatnama.

D) Interest/Dividend from the FDR or Government securities, compensation, cost received as per the order of any court.

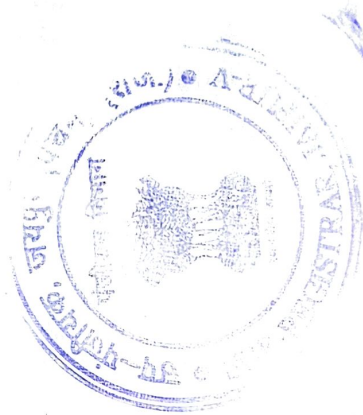

E) All the funds whichever lying with the Rajasthan High Court Bar Association in the name of Welfare Fund Shall stand transferred to this Trust.

F) The following funds shall also be admitted to the fund :-

- I. Rs. 21000/- by every Senior Advocate practising in Rajasthan High court, Jaipur and is Member of RHCBA, Jaipur and shall also include Senior Advocate Designated later.
- II. Rs. 21000/- by every past and present President of RHCBA, Jaipur.
A member falling in more than 1 categories mentioned above shall be required to pay any of the one category.
- III. Rs. 21000/- by each member of the Bar Council elected from time to time and also the future members of Bar Council
- IV. The funds received under sub clause A, E and F (I, II and III) shall form the corpus of the fund which shall not be withdrawn.
- V. The fund which is received under sub clause B, C and D shall form the fund available for distribution.
- VI. The Trustee Committee will sit every year in the month of April and after taking into account of the past year income and the past year death payments and ex-gratia payments, will decide the amount available in the current year for payment to the dependants/nominee of the deceased member and payments to the member as ex-gratia. This exercise has to be done every year with the help of a chartered accountant/financial expert be taken in determining such payments so that the fund can run for long indefinite period. This determination of such amount payable per death must be done every year in advance and this amount so fixed shall remain static for the whole financial year or until the new determination is done by the newly appointed trustee committee after election of the Bar association.

For the First year the payable amount on death will be determined on the basis of number of vakalatnama/memo of appearances filed before Rajasthan High court, Jaipur and number of death of advocates in the immediate past year.

The Trustees shall invest, apply, or utilize the Trust Fund solely for the objects of the Trust and the manner in which it is provided.

6. Trustee Committee

- a) The Trust shall be managed by not less than 2 and not more than 7 Trustees at a time.
- b) Trustees shall hold office for a term of 1 year or until 15 days after next annual election of RHCBA, Jaipur takes place and shall be eligible for re-appointment except ex-officio.
- c) The Elected President and Secretary of the Rajasthan High Court Bar Association, Jaipur Bench shall be Ex-Officio Trustees of the Trust and the President of Rajasthan High Court Bar Association shall be the Chairmen of the Trust and General Secretary of Rajasthan High Court Bar Association shall be the Secretary of the Trust.
- d) The Advocate General of Rajasthan or his nominee which can be any Additional Advocate general functioning at Jaipur to be Trustee of the Fund, such Nomination can be changed annually after every election of Rajasthan High Court Bar Association Jaipur.
- e) Two (2) Designated Senior Advocates to be elected by the new Executive Committee of the association within 15 Working days of their election to act as a Trustee. Such Trustee will work until the new elected body in the subsequent year nominates the other new trustee. Out of these Two (2) Designated Senior Advocate One (1) should be of more than 10 Years standing as a Senior Advocate.

f) Two (2) past Presidents to be elected as Trustee to the Fund within 15 Working days of the new elected body and Such Trustee will work until the new elected body in the subsequent year nominates the other new trustee.

7. Disqualification and removal of elected member of Trust Fund.

No person shall be elected and continue to be as a member of Trust Fund under clause 6 if he :

- (a) is of unsound mind and stands so declared by a competent court; or
- (b) is, or at any time has been, adjudicated insolvent; or
- (c) is or has been convicted by a criminal court for an offense involving moral turpitude, unless such conviction has been set aside; or
- (d) is a defaulter to the fund; or
- (e) is debarred from practicing on the ground of professional or other misconduct; or
- (f) ceases to be an advocate under the Advocates Act, 1961 (Central Act 25 of 1961)

8. Resignation and casual vacancy of elected Member

(1) Any member elected under clause 6 by the RHCBA, Jaipur may resign his office by giving One month's notice in writing to the Chairman of the Trustee Committee and on such resignation being accepted by the Chairman, Trustee Committee, the said member shall be deemed to have vacated his office.

(2) If any member elected under clause 6:-

- (a) becomes subject to any of the disqualifications mentioned in Clause 7 ; or
- (b) dies or become incapable of holding office of trustee ; or
- (b) is absent without leave from the Trustee Committee for more than three consecutive meetings of Trustee Committee,

this seat shall thereupon become vacant.

(3) A casual vacancy of a elected member arising under Clause (1) and (2) shall be filled in as soon as possible in the same manner and for the remaining term as is mentioned in Clause 6.

9. Vesting and application of Fund

The fund shall vest in and be held and applied by the Trustee Committee subject to the provisions and for the purposes of this Act.

10. Functions and Powers of trustee committee

- (1) The Trustee Committee shall administer the Fund.
- (2) In the administration of the Fund, the Trustee Committee shall,
 - (a) collect, preserve, manage and utilise the Fund;
 - (b) hold the amounts and assets belonging to the Fund in trust;
 - (c) receive applications for admission or re-admission to the fund and dispose of such applications within thirty days from the date of receipt thereof;
 - (d) receive applications from the members of the Fund, their nominee, dependents or legal representatives, as the case may be, for payment out of the Fund, and conduct such enquiry as it deems necessary for the disposal of such applications and shall dispose of the applications within thirty days from the date of receipt thereof;
 - (e) record in the minutes book of the Trustee Committee its decision on the applications received under clauses (c) and (d);
 - (f) pay to the applicant death or ex-gratia claims as approved by the trustee committee in accordance with the provision of trust deed;
 - (g) send such periodical and annual reports, as may be prescribed, to the Rajasthan High Court Bar Association, Jaipur;
 - (h) communicate to the applicant by Email or by other electronic medium or by post its decision on the applications for admission or re-admission to the Fund or claims to the benefit of the Fund;

- (i) such other works which are necessary to achieve the above objects of the trust fund.

11. Funds and investment

(1) The Trustee Committee shall deposit all moneys and receipt forming part of the Fund in any Scheduled Bank or Post Office or invest the same in any corporation owned or controlled by the Central Government or the State Government or in deposits/debentures/securities floated by the Central Government or the State Government or in any other manner as the Trustee Committee may, from time to time, decide with the approval of Rajasthan High Court Bar Association, Jaipur. The trustee committee shall not deposit the fund in any private or non-scheduled bank or a cooperative bank or a cooperative society or any private person or institution.

(2) All amounts due and payable under this Act and all expenditure relating to the management and administration of the Fund shall be paid out of the Fund. The office staff which will be looking into the affairs of the fund shall be paid salary out of the fund of Rajasthan high court bar association and not from the Trust fund.

12. Bank Account

That the funds of the Trust Fund shall be kept in a Scheduled Bank or be invested in Government securities. Such Bank Account or deposits shall be operated by the signature of Secretary and Counter signed by the chairmen and one of the Trustee.

13. Accounts and Audit

(1) The Trustee Committee shall keep and maintain books of accounts and other books in such form and in such manner as may be prescribed.

(2) The accounts of the Trustee Committee shall be audited annually by a Chartered Accountant appointed by the Rajasthan High Court Bar Association, Jaipur.

(3) The accounts of the Trustee Committee as audited by the Chartered Accountant together with his audit report thereon shall be forwarded to the Rajasthan High Court Bar Association, Jaipur by the Trustee Committee and the Rajasthan High Court Bar Association, Jaipur may issue such

Recommendations as it deems fit, to the Trustee Committee in respect thereof.

GENERAL SECRETARY

(4) The Trustee Committee shall pay from the Fund the charges for the audit.

(5) A copy of annual audit report and the audited accounts shall be sent every year to Rajasthan High Court Bar Association, Jaipur.

14. Powers and duties of secretary

The Secretary of the Trustee Committee shall:-

(a) be the chief executive authority of the Trustee Committee and responsible for carrying out its decisions;

(b) represent the Trustee Committee in all suits and proceeding for and against the Trustee Committee;

(c) authenticate by his signatures all decisions and instructions of the Trustee Committee;

(d) operate the bank accounts of the Trustee Committee jointly with the Chairman of the Trustee Committee or his nominee as per the provision of trust deed;

(e) convene meetings of the Trustee Committee and record its minutes;

(f) attend the meetings of the Trustee Committee with all necessary records and information;

(g) maintain such forms, registers and other record as may be prescribed from time to time and do all correspondence relating to the Trustee Committee;

(h) prepare an annual statement of business transacted by the Trustee Committee during each financial year;

(i) To appear before any Court or Arbitrators in the matter of any dispute raised on behalf of the trust and to contest the same to the best of interest of Trust Fund and to keep Trust and Rajasthan High Court Bar Association, Jaipur in full knowledge of the same. It should be endeavour of the Secretary to conciliate the matter in the best interest of the Trust Fund in

(j) do such other acts as may be directed by the Trustee Committee.

15. Membership in the Fund

(1) Every advocate practising before Rajasthan High Court, Jaipur shall apply with specified fee to the Trustee Committee for admission as a member of the fund along with proof of his 5 appearances before Rajasthan High Court, Jaipur in such form as may be prescribed and continue to submit proof of 5 appearances every year at the time of payment of annual fee.

Provided that this condition shall not apply to the Designated Senior Advocates.

Provided further that the Trustee committee may require any of its members to produce proof of their practicing regularly in Rajasthan High court, Jaipur.

(2) On receipt of an application under sub-sec. (1), the Trustee Committee shall make such enquiry as it deems fit and either admit the applicant to the Fund or, for reasons to be recorded in writing, reject the application:

Provided that no order rejecting an application shall be passed unless the applicant has been given an opportunity of being heard against rejection of his application.

(3) Every member shall pay in advance an annual subscription to the Fund on or before the 30th June of every year at the following rates, namely:-

(i)	Where the standing of the Advocate at the Bar is less than five years-	Rs. 1000/- per annum for 5 Years
(ii)	Where the standing of the Advocate at the Bar becomes five years or is less than ten years-	Rs. 1500/- per annum

Provided that a member of the fund may deposit in lump-sum a sum of Rs. 21,000/-] and in that event he shall not be required to pay annual subscription. Any member who want to convert his membership from Annual to One time he can do so by making payment of Rs. 21000/-. The Annual/Onetime fee prescribed may be changed by the Trustee Committee with the approval of RHCBA, Jaipur.

Provided further that the prospective member shall pay the full subscription of the current year along with the admission fee to the fund.

Provided further that all the Life members of the existing welfare fund of the Rajasthan High Court Bar Association, Jaipur shall be deemed to be life member of this Trust. Those members who are ordinary members are only requited to make payment of remainder amount which fall short of Rs. 21000/- in the same manner as provided above.

Provided also that if annual subscription of current year is not paid on or before 30th June, the member of the Fund shall be liable to pay on the amount of arrear an interest at the rate of Rs. 1.50 per hundred per month from the date on which subscription becomes due.

(4) Any member who fails to remit the annual subscription on or before the due date mentioned in above clause shall, upon notice in writing or by Email or by any Electronic communication calling him to make payment of the due subscription within 1 month. If the default remains continued for a period of 3 years the member or their dependent shall not be entitled to any benefit and their name shall be deemed to have been removed. Although

(5) A person removed from the membership of the Fund under the above clause shall be re-admitted by the Trustee Committee to the Fund on payment of the arrears of subscription due against him alongwith interest thereon at the rate of 1.50 rupees per hundred per month from the date the subscription became due and 400/- rupees as readmission fees within one year from the date of his removal:

(6) A member of the Fund may, at any time after his admission to the membership of the Fund, make a nomination in the prescribed form appointing one or more person to receive the benefits arising from his membership of the Fund in the event of his death.

(7) If a member nominates more than one person under above clause, he shall specify in the nomination the amount or share payable to each of the nominees in such manner as to cover the whole of the amount that may be due to him.

(8) A member may at any time cancel his nomination by sending notice in writing to the Trustee Committee and in that event, he shall be entitled to make a fresh nomination during the continuance of his membership in accordance with above clause.

(9) A member who ceases to practice in Rajasthan High Court, Jaipur shall automatically cease to be a member of the Fund and such member shall not be entitled to receive any amount of subscription deposited by him.

(10) A member of the Fund, who is punished for professional misconduct under the Advocates Act and is suspended from practice, shall not be entitled to benefits of the Fund for the period of such suspension nor shall be required to pay yearly subscription for such period.

(11) In the event of death of a member of the Fund and if no nomination is made or the nomination made is withdrawn then the amount to which the member was entitled shall be paid at the first instance to spouse as a deemed nominee, or where there is no spouse available to receive, to his

dependents provided they jointly apply for the same and in absence thereof,

to his legal heirs subject to their obtaining a succession certificate from the competent court.

(12) Any application received in this clause shall be disposed of by the Trustee Committee within one month but not exceeding three months and the application be disposed after such enquiry as it deems necessary.

16. Restriction on benefits from the Fund

(1) Notwithstanding anything to the contrary contained in this deed, if any Advocate after his admission to the Fund joins an employment, he shall cease to be a member of the Fund and shall not be entitled to any benefit. Even if later he again switch over to the profession he has to apply De Novo.

(2) Any person who have joined the RHCBA, Jaipur after voluntary retirement/compulsory retirement/superannuation/removal/dismissal shall not be admitted as member of the Trust Fund. Any person who joined the RHCBA, Jaipur after the age of 40 Years shall not be eligible for becoming a member of the Trust Fund and thus shall not be entitled to any benefit of The Trust Fund.

17. Printing and distribution of Vakalatnama by Trustee committee/RHCBA, Jaipur

1) Every advocate practising before Rajasthan High Court Jaipur Bench shall file a vakalatnama before High Court Registry duly issued by RHCBA, Jaipur Office on payment of Rs. 110 each or as the fee prescribed from time to time by Trustee committee duly approved by RHCBA, Jaipur. The fee of vakalatnama shall be deposited in the bank account directly by the member concerned. No cash shall be received in the office of Trust Fund or RHCBA, Jaipur. The Trustee committee can relax this position for a period of first 6 months by providing duly accounted vakalatnama to the members after obtaining cash. All cash received have to be deposited the very second day in the bank and the cash of such sale cannot be retained by any of the employee.

2) RHCBA, Jaipur office on behalf of the Trust Fund shall issue an electronic printed vakalatnama of value of Rs. 100 or as may be prescribed. Only such vakalatnama shall be filed by the advocate members of Rajasthan High Court Bar Association in High Court Registry. Every such vakalatnama shall have a serial number and a water mark and if so required and the IT expert so provides for security reasons it can be changed so that piracy can be avoided. The trust committee can decide in this regard in their meetings. Remaining 10 Rs. shall be retained by Rajasthan High Court Bar Association Jaipur towards printing of vakalatnama and salary of the clerk and maintenance of records, audit, expense etc.

3) The custody of the vakalatnama shall be with the office of the Trustee Committee. A day to day accounting of the vakalatnama sold by electronic payment or by cash payment shall be maintained and the secretary of the fund is bound to verify the correctness of the same. The correctness of the maintaining sales record and funds have to be inspected by a shorter committee constituted by the Trustee Committee at a regular short interval not exceeding 3 months.

4) The Trustee Committee/ RHCBA, Jaipur shall keep proper accounts of the vakalatnama in such form and in such manner as may be prescribed.

18. Meeting of the Trustee Committee

The Trustee Committee shall meet, at least once in three calendar months or more often, if found necessary, to transact business under this Act or the rules made thereunder.

19. Manner of holding meeting

(1) One-half members of the Trustee Committee shall form the quorum for the meeting of the Committee.

(2) The Chairman or in his absence a senior most senior advocate shall preside over the meeting of the Trustee Committee.

(3) The meetings of the Trustee Committee shall ordinarily be held at the office of the RHCBA, Jaipur office.

(4) Any matter coming up before the meeting of the Trustee Committee shall be decided by a majority vote of trustees but not less than 4 and voting at the meeting and in the case of an equality of votes, the Chairman or the member presiding over the meeting shall have a casting vote.

20. Ex-gratia grant to a member of the Fund

(1) The Trustee Committee, on an application submitted to it, and after being satisfied about the genuineness of the claim, may allow ex-gratia grant to a member from the fund in following manner:-

(a) in case of hospitalization involving a major surgical operation; or

(b) if he undergoes open heart surgery, organ transplantation/removal/dissection or is suffering from paralysis, cancer, unsoundness of mind, AIDS, paraplegia/brain hemorrhage or disablement certified by a Medical Board to be more than fifty per cent.

(2) The grant so allowed shall not exceed a sum of Rs. 25000/- in cases falling under clause (a) and Rs 100000/- in cases falling under clause (b) :

Provided that the member admitted as an advocate or re-admitted after the age of 40 years shall not be entitled to receive any ex-gratia grant.

(3) That every member applying for ex-gratia must disclose in his application about the details of his medi-claim policy, claim received or pending, ex- gratia received or applied or pending before Rajasthan High Court Bar Council or any other Bar Association of which he is a member. The grant of ex-gratia is not the reimbursement but an attempt to help the advocate to some extent in meeting his medical expenses.

21. Miscellaneous

A.) Any dispute raised by any member or legal representative or nominee of the deceased member with regard to payment out of Fund shall be referred for Arbitration by Three (3) Designated Senior Advocates practising at Rajasthan High Court Jaipur Bench. Their decision shall be final and binding on the parties. Seat of the Arbitration will be at JAIPUR.

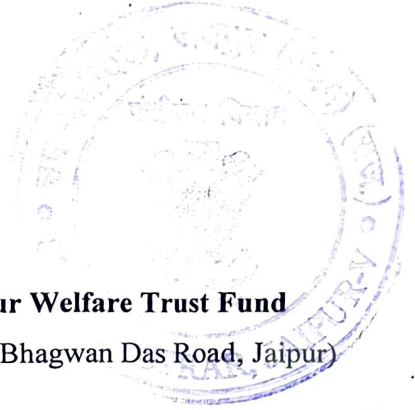
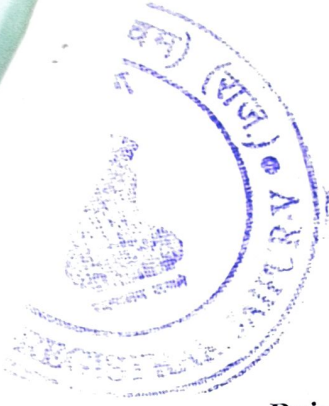

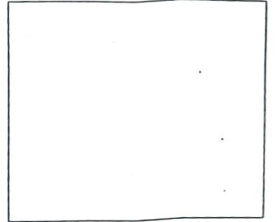
